Buckwheat Class I

Buckwheat proposed for supply - Class I whole grain.

Buckwheat produced by GOST 19092-92. Being used in manufacturing child nutrition and cultivated on fields without using pesticides.

Present State Standard circulated on a buckwheat Class I, obtained from buckwheat grain by separating whole grain from seed coat.



This particular wheat meets the requirements presented in table 1.

Annotation:

1. Wheat produced from not steamed grain of buckwheat permitted having a damp:
 - 1.1. For current consumption - not more than 15%;
 - 1.2. For long-term storage and preschedule delivery not more than 14%.
2. Determine the cooking time of buckwheat regularly but not less than 1 time per month.
3. Pesticides, toxic, micro-toxic elements substance do not exceed permissible levels defined by bio-medical demands and sanitary regulations of the food commodities qualities and edible products by the Ministry of Health in Russian Federation.
